Subject : The Revenue Department (RD) gives support to disabled sportsmen in collecting

for international tournament

28th May 2012, Mr. Kittiratt Na-Ranong, Deputy Prime Minister and Minister of Finance, inaugurated in opening ceremony of the disabled badminton tournament "RD Relations to disabled badminton players" This occasion, Dr. Satit Rungkasiri, Director-General of the Revenue Department, Khunying Pattama Leesawasdrakula, Honorary Chairman of The Badminton Association of Thailand Under His Majesty's Patronage, as well as disabled players, sponsors and press also joined the event being held at a Badminton Court of Thailand Tobacco Monopoly, Rama IV Road, Bangkok.

Badminton tournament for the disabled "RD Relations to disabled badminton players" sponsored by many organizations and private sectors aimed to collect money for Thai disabled sportsmen to participate in the international tournaments and ascertain a joy of living a normal life with dignity and value of human being.
